Setup/Breakdown: All Exhibitors must be set up and ready to sell by 3:45pm on the day of the event. Exhibitors may start setting up at 3:00pm. Breakdown can start no sooner than 7:00pm and must be completed by 7:30pm. No vendor is to close before the official closing time. Sellers are responsible for their selling spaces. \*Before leaving, be sure you area is clean and trash free.

Exhibitor tables and booths must be manned at all times and intact until event closes at 7:00pm.

Exhibitor will be fully responsible for any loss or damage to his or her property by theft or casualty. Each Exhibitor is responsible for the conduct of his employee or representative and activities shall not detract from the image or welfare of the event.
